Financial and Social Impact

Since capitalizing the Investment Fund in 2013:

- \$10,732,000 deployed in the form of loans, grants, and equity investments
- 50 projects executed or advanced through provision of development services, which created 703 new residential units, delivered 639,000 square feet of tenant-ready commercial space, and preserved 39 underutilized historic buildings
- major community facilities developed as result of Catalytic Fund real estate services, two of which serve over 20,000 at-risk individuals annually
- \$286,316,000 in total investment represented by projects, a 26-times leverage of Catalytic Fund investment
